

## Official Notice: 2024 Election Schedule

In accordance with **Section 3.05, Election of VTCI Officers**, to provide fair and equitable notice to all members and potential candidates, the Board of Directors is announcing the **2024 Election Schedule** with the following positions on the ballot:

- **President**
- **North Central Regional Director**
- **South Central Regional Director**
- **Southeast Regional Director**
- **International Regional Director (Europe & Pacific Rim)**

Interested candidates must comply with the provisions of **Section 3.05.100, Nomination Criteria**, outlining minimum standards for each office.

Petitions shall be required in accordance with the provisions outlined in **Section 3.05.200, Nomination of Candidates**. The deadline for nominating petitions to be received by the **Executive Secretary** has been established as **January 1, 2025**. Nominating petitions are available for download from the VTCI website.

When multiple nominations are received for an elective office, the **Executive Secretary** shall notify the Board of Directors of the need to schedule an election and prepare an official ballot no later than **January 31, 2025**, in accordance with the provisions of **Section 3.05.300, The Election Process**. The official ballot will be available for download from the VTCI website and will also be published in the **March/April 2025** issue of the SCOOP.

Candidates' submittals, along with their statements of qualifications and/or goals, will be posted to the VTCI website – [www.vintagethunderbirdclub.net](http://www.vintagethunderbirdclub.net) – upon receipt. Should no nominations and/or petitions be received from candidates *other* than an incumbent by **January 1, 2025**, the incumbents' names will be submitted to the Board of Directors for confirmation in a vote of confidence at the **Board of Directors' Annual Meeting** to be convened at the **2025 International Convention**, in accordance with **Section 3.05.400, Incumbent Retention and Affirmation**.

**Voting will continue with ballots accepted/postmarked through 11:59 PM, April 30, 2025**. Results will be tabulated by the **Executive Secretary**, confirmed electronically by the Board of Directors no later than **June 1, 2025**, and the candidates notified immediately thereafter. Formal affirmation will occur at the **Board of Directors' Annual Meeting** to be convened at the **2025 International Convention** and final results posted on the website and published in the September/October issue of the SCOOP.
